**object : World cup in fin swimming**

I have to inform you that the CMAS Steering Committee has taken the following decisions during its last meeting held on January 28<sup>th</sup>, 2006.

Taking in account

1. the fact that you have personally asked and received the agreement of the CEDIP President to nominate this event as a CEDIP one,
2. the fact that your federation is affiliated to the CMAS Sports Committee ( Finswimming )
3. the fact that *CEDIP is not recognised or affiliated to CMAS and that CMAS has never signed any agreement with CEDIP*
4. the fact that CEDIP is only involved in scuba diving and not in finswimming
5. the fact that on the calendar received only the CEDIP logo appears and not the CMAS one
6. the fact that the annexed rules of this event are not in accordance with the CMAS World Cup rules
7. the fact that CMAS is recognised by the IOC as the international federation involved in finswimming what means that finswimming is a CMAS property and that no one affiliated federation has the right to sale or to give it to another organisation

***the CMAS Steering Committee has decided to not recognise the 3 rounds and the final presented as CMAS events and that these events will not be written in the CMAS Competitions and Championships Calendar.***
